### ABSTRACT

OTS 2025 Scheme - Extending of One time Settlement Scheme for one more month and to incorporate modifications in the approved OTS scheme – Sanction accorded – Orders issued.

### **ORDER**

The OTS-2025 scheme is implemented in KSEBL as per B.Os read as 1<sup>st</sup> and 2<sup>nd</sup> above with intimation to KSERC from 01.05.2025 to 31.07.2025. As per the above scheme, consumers with arrears for more than two years are granted reduced interest rates for favour of settlement. This scheme is open for arrears coming under the head of electricity charges and also to arrears accumulated as part of pole rental of Cable TV operators.

In the review meeting convened by the Chairman and Managing Director, KSEBL on 17.07.2025, considering the requests from field office to extend the OTS scheme for one more month, it was suggested to revise the time schedule of OTS 2025 as follows.

20.08.2025 - Last date of accepting application form

31.08.2025- Last date to issue of demand notice and remittance of first instalment by the consumer.

Now the field officers have requested for extending the rebate to 5% given on principal if the entire principal and total reduced interest is remitted in one lump, which is a general condition for OTS-2025 for bills raised under Section 127 (6) also. They have also suggested to include

the bills raised under section 135 in the OTS Scheme, if the consumer has already remitted the compounding fees in full. It was also requested for the settlement of transmission development charge arrears under OTS 2025 Scheme, since the transmission development charges are part of deposit work estimate.

The matter was placed before the Full Time Directors as per note read as 4<sup>th</sup> above .

Having examined the matter in detail, meeting of Full Time Directors held on 30.07.2025 passed the following resolutions.

- a. Resolved to extend the approved OTS-2025 scheme be extended for one more month ie till 31.08.2025 with the following revised time schedule  
20.08.2025 - Last date of accepting application form  
31.08.2025 - Last date to issue of demand notice and remittance of first instalment by the consumer
- b. Further resolved that the rebate to 5% given on principal if the entire principal and total reduced interest is remitted in one lump, which is a general condition for OTS -2025, shall be made applicable for bills raised under Section 127(6) also.
- c. Further resolved that the cases billed under Section 135 and compounding fees remitted in full, shall be referred to the Legal Advisor & Disciplinary Enquiry Officer, KSEBL for legal opinion for including in the OTS – 2025 scheme.
- d. Further resolved that the arrears in the transmission development charges be settled in OTS – 2025 scheme without waiver of principal amount except installment facilities for remitting the estimate amount.
